

Terms and Conditions

Participants Responsibilities:

1. All riders are required to submit to Gunslinger Motorcycle Tours, LLC a valid driver's license with a motorcycle endorsement and a copy of the participants' valid insurance coverage 30 days prior to tour date for multiple day tours and for single day tours prior to tour date.
2. Participants are responsible for their own airline reservations and tickets.
3. Motorcycle rentals, gasoline, meals (except the Welcome Dinner on the first night on stated tours), incidentals, hotels before and after your tour.

Payment for Tours – All prices are in U.S. Dollars. Payments are made through Google Buy Now. Full payment is due at the time of reservation. In addition to the payment and at the time of payment signed Liability waiver and Release Forms and Terms and Conditions Forms must be signed and either faxed or mailed to Gunslinger Motorcycle Tours, LLC, one per participant.

Refunds and Cancellations – Gunslinger Motorcycle Tours, LLC seldom cancels a tour, however, we reserve the right to do so when absolutely necessary for the following reasons:

1. Dangerous weather conditions
2. Other conditions beyond our control

In the event of such an occurrence, Gunslinger Motorcycle Tours will refund participants payment or apply it toward another tour within 12 months of cancellation. Gunslinger Motorcycle Tours, LLC is not responsible for any travel expenses incurred.

Cancellations for Tours – If participants cancel a tour 35 days prior to the tour date, participants will be refunded the full amount minus a 15% processing fee. Cancellations made after the 35 day minimum will not be refunded.

Weather – Gunslinger Motorcycle Tours, LLC has planned your tour for suitable motorcycle riding in that region which depicts the best weather for that time of year. However, on occasion, the tour maybe faced with unfavorable or severe weather and Gunslinger Motorcycle Tours, LLC cannot accept responsibility for delays or modifications.

Our Responsibilities – All Gunslinger Motorcycle Tours, LLC tours are continually refined and or updated to maximize the enjoyment of our guests. We reserve the right to modify, without

notice to our guests, any tour as needed to accommodate operating needs or circumstances beyond our control. This includes, but is not limited to, hotel arrangements, routes, and itinerary. In the event substitutions are made every effort will be made to insure that all features of the tour are of similar to those originally planned.

I certify that I am duly licensed and competent to operate a motorcycle in a safe manner, and the vehicle is in a safe operating condition. I will be riding on public roads, highways and I am solely responsible to determine the speed and operational characteristics of my motorcycle while participating in the tour. I agree to ride within my riding ability and agree to not be influenced by any group or pack mentality to ride faster than is within my ability or the limits of what is considered safe riding conditions. Nor will I be influenced by riding displays by neither fellow tour participants nor tour guides that could be considered unsafe.

I certify that I have no known physical or mental impairment that may affect my safety or the safety of group. I understand that the choice of wearing a helmet or other protective gear is solely my own and that I am responsible for my compliance with all state laws, including those regarding of helmets.

I understand that Gunslinger Motorcycle Tours, LLC accepts no responsibility for loss of or damage to my personal belongings including my motorcycle. Further, I certify that I am not under the influence of any narcotic, alcohol, or other drug that may impair my understanding or judgment and that I will not at any time during the tour operate my motorcycle under the influence of any narcotic, alcohol, or other drug.

I agree that Gunslinger Motorcycle Tours, LLC may use my likeness, name, photograph or voice. I consent to such use and hereby waive any rights or claims to privacy I have in connection with this tour, unless prearranged and agreed upon by Gunslinger Motorcycle Tours, LLC.
